

## CONTRACT AGREEMENT NO. 230079

### For the Procurement of Various Materials for the Preventive Maintenance of Yamaha Outboard Motors (OBM) for use by Law Enforcement Department

WHEREAS, the Entity requested for proposals from several suppliers by sending the latter a Request for Quotation (RFQ) and through posting the RFQ in the Philippine Government Electronic Procurement System (PhilGEPS), SBMA official website and Facebook Page, among others, pursuant to a duly approved request for procurement through small value procurement, in connection with the project, **Procurement of Various Materials for the Preventive Maintenance of Yamaha Outboard Motors**, and has accepted a Bid by the Supplier, being the lone and complying bidder, for the supply of those goods and services in the sum of **Three Hundred Forty One Thousand Nine Hundred Fifty Pesos only (P341,950.00)** (hereinafter called "the Contract Price").


#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. General Conditions of Contract;
  - ii. Special Conditions of Contract;
  - iii. Als Marine Center Corporation's Quotation;
  - iv. End-User's Materials' List / Scope of Works, as stated in the Quotation Form, if any and all other documents or statements submitted;
  - v. Purchase Evaluation Memo **dated March 20, 2023**;
  - vi. Minutes of Negotiation and Supplier's/Contractor's Signature; if any
  - vii. Performance/Warranty Security; if any
  - vi. Notice of Award of Contract; and the Supplier's/Contractor's conforme thereto; and
  - vii. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in connection with the project and the RFQ, including, but not limited to, the RFQ, the Supplier's mayor's/business permit, PhilGEPS registration number, and Omnibus Sworn Statement. **Winning Supplier/Contractor agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Three Hundred Forty One Thousand Nine Hundred Fifty Pesos only (P341,950.00)** or such other sums as may be ascertained, **Als Marine Center Corporation** agrees to **Procurement of Various Materials for the Preventive Maintenance of Yamaha Outboard Motors** in accordance with his/her/its Quotation.

4. The **SUBIC BAY METROPOLITAN AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Request for Quotation.






