## RESOLUTION NO. 015-FB-2023

**WHEREAS**, the SUBIC BAY METROPOLITAN AUTHORITY (SBMA) advertised the Invitation to Bid for the procurement of the **Service Provider of Accommodations for Various Subic Bay Metropolitan Authority Activities and Events** posted on the SBMA website, the G-EPS and in a conspicuous place within the Subic Bay Freeport Zone for 14 days;

**WHEREAS**, in response to the advertisement dated March 15, 2023, no prospective bidder attended the Pre – bid Conference for the project held on March 23, 2023. Thereafter, no bidder purchased the bid documents;

**WHEREAS**, during the Submission of Bids scheduled on April 14, 2023, no bidder submitted its bid thereon;


**WHEREAS**, under Sec. 35.1 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, when no bids are received, the BAC shall declare the bidding a failure;


**NOW, THEREFORE**, premises considered, **WE the Members of SBMA Bids and Awards Committee (BAC) for Goods and Services, hereby RESOLVED to declare the bidding for the Service Provider of Accommodations for Various Subic Bay Metropolitan Authority Activities and Events a failure.**
