RESOLUTION NO. 070-FB-2020

WHEREAS, the SUBIC BAY METROPOLITAN AUTHORITY (SBMA) advertised the Invitation to Bid for the procurement of the **Services and Materials for the Supply, Delivery and Installation of Premium Quality Fabric Window Combi-Blinds at Various SBMA Office Buildings** by posting on the SBMA website, the G-EPS and in a conspicuous place within the Subic Bay Freeport Zone for 14 days;

WHEREAS, in response to the advertisement, while two (2) prospective bidders attended the Pre – bid Conference for the project held on July 1, 2020 only one (1) proponent purchased the bid documents, RGSA CARPETS AND INTERIOR PRODUCTS, INC.;

WHEREAS, during the Submission of Bids scheduled on July 15, 2020, only the aforementioned bidder was able to submit its bid;

WHEREAS, during the Opening of Bids scheduled on August 25, 2020 for the said project, the lone bidder, RGSA CARPETS AND INTERIOR PRODUCTS, INC., was found to have ‘failed’ by the Bids and Awards Committee (BAC) for Goods and Services during the preliminary examination of the bids for the non-submission of the Other Technical Documentary Requirements under Tab “L”, *i.e. Brochures of the offered product/items*;

WHEREAS, on August 28, 2020 RGSA CARPETS AND INTERIOR PRODUCTS, INC. submitted a Request for Reconsideration;

WHEREAS, on September 4, 2020, the Committee resolved to deny the Request for Reconsideration submitted by RGSA CARPETS AND INTERIOR PRODUCTS, INC.;

WHEREAS, on September 18, 2020, the letter of denial, which was sent thru private courier, was received by RGSA CARPETS AND INTERIOR PRODUCTS, INC.;

WHEREAS, no appeal was made by the RGSA CARPETS AND INTERIOR PRODUCTS, INC. within the allowable period;

WHEREAS, under Section 35.1 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, when all prospective bidders are declared ineligible, the BAC shall declare the bidding a failure;

NOW, THEREFORE, premises considered, **WE the Members of SBMA Bids and Awards Committee (BAC) for Goods and Services, hereby RESOLVED to declare the bidding for the Services and Materials for the Supply, Delivery and Installation of Premium Quality Fabric Window Combi-Blinds at Various SBMA Office Buildings a failure.**

Accordingly, in order to determine the reason for the failed bidding, a mandatory review and evaluation of the terms, conditions and specifications in the bidding documents, including its cost estimates shall be conducted.






RESOLVED further, that after the necessary revisions in the terms, conditions and specifications in the bidding documents resulting from the aforementioned mandatory review and evaluation, **to conduct another procurement process for the project through public bidding.**


